

Can Measure E Bond dollars pay for positions?

Board Resolution #24/2023-2024

Page 2 Paragraph 7:

WHEREAS, the Board hereby directs that, in accordance with Opinion No. 04-110 of the Attorney General of the State of California, the restrictions in Proposition 39 which prohibit any bond money from being wasted or used for inappropriate administrative salaries or other operating expenses of the District shall be monitored by the District's Independent Citizens' Oversight Committee; and

Page 3 Section 3:

Section 2 (a) that the proceeds of the sale of the Bonds shall be used only for the purposes set forth in the ballot measure and **not for any other purpose**, **including teacher or administrator salaries or other school operating expenses**, **or staff housing**;

Board Resolution #24/2023-2024 - Exhibit B -Project List

EXHIBIT B Page B-1: the Board of Education determines that the District must:

- (i) Upgrade classrooms, science, technology, and engineering labs; and
- (ii) Update classrooms and classroom technology for current educational standards; and
- iii) Adhere to specific fiscal accountability safeguards:
 - (d) No money used for administrators' salaries.

California Constitution, Article XIIIA, Section 1 (b) (3), states the funding must be for "the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, or the acquisition or lease of real property for school facilities." Bond Funds cannot be used for operating expenses such as teacher or general administrative salaries but can be used for the administration of the school construction process, including planning, design, engineering, and project management and control.

Legal Citation

Can positions supporting Bond projects be charged to Measure E?

Yes, the California Attorney General has determined that a school district may use Proposition 39 School Board proceeds to pay the salaries of district employees who perform administrative oversight work or construction projects authorized by a voter approval bond measure (See No. 04-110 (2004).

This Attorney General Opinion was quoted with approval by the court of appeal in *San Lorenzo Valley Community Advocates for Responsible Education v. San Lorenzo Valley Unified School District* 139 Cal.App4th 1356.







